# POLICIES AND PROCEDURES RELEASE, WAIVER OF LIABILITY, ASSUMPTION OF RISK AND INDEMNIFICATION AGREEMENT

In consideration for my dog (the "Guest") being permitted to be a client at Bark Central Day Care and Boarding Resort for the day or overnight boarding, I hereby enter into this Policies and Procedures, Release, Waiver of Liability, Assumption of Risk, and Indemnification Agreement (the "Agreement") and make the following representatives and agree to all of the following policies, procedure, terms and conditions.

- 1. I represent and certify that all the information contained herein and in the Guest Application in true and accurate.
- 2. OWNERSHIP: I represent and warrant that I am the sole owner of the Guest.
- 3. **GUEST REQUIREMENTS:** I represent and warrant that my Guest meets the following requirements and that he/she has: (a) successfully completes the Bark Central Guest Behavioral Interview; (b) is four months of age or older; (c) is spayed or neutered (if over six months of age); (d) is current on his/her Rabies, Distemper, and Bordetella vaccinations; (e) has not been exposed to rabies, distemper, or been ill within a thirty day period prior to attending Bark Central; (f) is in good general health and free of ticks and fleas; (g) is not aggressive or protective of toys; and (h) shall attend Bark Central with a quick release collar that contains an identification tag bearing the Guest's name and owner's current contact information. My Guest will enter and exit the Bark Central facility with a leash.
- 4. DUTY TO DISCLOSE: I have disclosed and shall continue to disclose on an ongoing basis, any and all medical or other conditions, including but not limited to personality concerns or behaviors that may effect, limit, or prevent my Guest's ability to participate in play time or otherwise attend Bark Central
- 5. **RESORT PARTICIPATION:** I understand that participation by my Guest in play time is at the sole discretion of Bark Central and that, in Bark Central's sole discretion, my Guest may be separated from other dogs or asked to leave for any reason.

- 6. **GUEST FEES:** I agree to pay for all camp fees, services, and products with the current and valid credit card number I have provided in the Guest Application, or by cash or check at the time I pick up my Guest after each visit to Bark Central. I agree to pay the rate for Day Care or Boarding in effect on the date my Guest is checked into Bark Central. I agree to pay all costs and charges for special services requested and all veterinary costs for my Guest during the time my Guest is in the care of Bark Central and agree that my Guest shall not leave Bark Central until all charges are paid in full.
- 7. **GUEST FOOD:** I understand that my Guest will not be provided lunch and that if I want my Guest to eat lunch, I must bring a sealed container marked with my Guest's name and feeding instructions. Bark Central will provide overnight guests with food in accordance with the instructions provided in the Guest Application.
- 8. **PERSONAL PROPERTY:** I agree that Bark Central shall not be responsible or liable for lost or damages to personal property belonging either to me or to my Guest. I also understand and agree that my Guest's collar may be removed in the play area to prevent injury to any dog. If my Guest causes any damage to the Bark Central facilities or equipment, I agree to be fully responsible and to pay for the full cost of any repair or replacement.
- 9. **CANCELLATION POLICY:** I understand and agree that: (a) I will be charged for a full day of day care if I fail to cancel my reservation twenty-four hours in advance; (b) I will be charged for a full day of boarding if I fail to cancel my boarding reservation at least forty-eight hours in advance; and (c) if my reservation is within three days of a nationally recognized holiday, I will be charged for a full day of day care or boarding if I fail to cancel my reservation at least seventy-two hours in advance.
- 10. **AGGRESSIVE DOGS:** I hereby certify that my Guest has not harmed or shown aggressive or threatening behavior towards any person or other dog. I understand that aggressive dogs are not permitted to attend Bark Central and that if my Guest acts aggressively or exhibits unacceptable behavior, he/she may be separated from the other Guests. Bark Central will use reasonable efforts to consult me about aggression and ways to address it, however, aggressive dogs may be asked to leave and not return to Bark Central and such determination shall be made at the sole discretion of Bark Central.
- 11. **ABANDONED DOGS:** I agree that I will not neglect to pick up my Guest from Bark Central by the time he/she is scheduled to leave without providing prior notification. I agree that any dog that is left at Bark Central without any contact, instruction or notification from me of the ability, willingness or plans to pick him/her up myself or by me personal representative, will be considered abandoned upon the fifth day of such notification failure. I understand that if I abandon by Guest at Bark Central,

Bark Central will, by default, become the legal owner and guardian of the Guest and Bark Central shall, in its sole custody, determine whether to place the Guest for adoption or to relinquish the Guest to unrelated shelter of its choice. I FULLY UNDERSTAND AND AGREE THAT IF I ABANDON MY DOG AT BARK CENRTAL, I MAY BE UNABLE TO RETREIVE POSSESSION OF MY DOG AND WILL HAVE NO RECOURSE AGAINST BARK CENTRAL AS PROVIDED HEREIN.

- 12. PARTICIPATION RISK: I UNDERSTAND AND AGREE THAT: (A) THERE ARE INHERENT AND POTENTIAL RISKS INVOLVED WITH INTEREACTIONS BETWEEN HUMANS AS WELL AS BETWEEN DOGS AND OTHER DOGS WHICH MAY RESULT IN PROPERTY DAMAGE OR BODILY INJURY, INCLUDING BUT NOT LIMITED TO, PERMANENT DISABILITY, SICKNESS OR DEATH TO HUMAN OR DOG; AND (B) THERE MAY BE OTHER RISKS NOT KNOWN NOR READILY FORSEEABLE AT THIS TIME (COLLECTIVLEY THE "RISKS"). I FULLY ACCEPT AND ASSUME ALL RISKS AND RESPONISIBILITY FOR ALL RISKS, INCLUDING WITHOUT LIMITATION, ALL LOSSES, COSTS, AND DAMAGES INCURRED AS A RESULT OF MY OR MY GUEST'S PARTICIPATION AT BARK CENTRAL, INCLUDING ANY VETERNERIAN EXPENSES INCURRED ON BEHALF OF MY GUEST. SICKNESS SHALL BE DEFINED TO INCLUDE ANY ILLNESS, INCLUDING BUT NOT LIMITED TO BORDETELLA (KENNEL COUGH) AND ANY OTHER FORM OF CONTAGIOUS ILLNESS.
- 13. **VETERNARIAN CARE AND LIABILITY:** If my guest becomes ill or if the state of my GUEST'S health otherwise requires professional medical attention, Bark Central may, in its sole discretion, engage the services of a veterinarian, administer medicine or give requisite attention to my GUEST and any and all expenses related thereto shall be by responsibility.
- 14. WAIVER, RELEASE AND INDEMNIFICATION: I HEREBY EXPRESSLY AND FOREVER WAIVE, DISCHARGE AND ALL CLAIMS, RELEASE FROM LIABILITY, SAVE, HOLD HARMLESS AND COVENANT NOT TO SUE Bark Central or its invitees, officers, directors, employees, volunteers, agents and representatives (collectively the "Releasees") from any and all injury, liability, claim, litigation, action, suit, costs, losses, damages, expenses, or demands (including reasonable attorney's fees) of every kind whatsoever arising out of, resulting from or relating in any way to; (a) any act omission of any Releasees, including but not limited to negligence; and )b) my or my Guest's attendance at Bark Central or in participation in activities at Bark Central (collectively the "Claims"). I FURTHER AGREE TO INDEMNIFY, DEFEND, SAVE AND HOLD HARMLESS the Releasees from any claims, litigation, actions, suits, damages, costs, attorney's fees, losses or injuries as the result of any such Claims. I AGREE THAT THIS RELEASE AND AGREEMENT TO INDEMNIFY SHALL BE BINDING ON ME AND MY SUCCESSORS, HEIRS, LEGAL REPRESENTITIVES AND ASSIGNS. I ALSO

EXPRESSLY AND FOREVER RELEASE BARK CENTRAL AND THE RELEASES FROM ANY DUTY TO PROTECT ME OR MY DOG(S) FROM INJURY OF ANY KIND, AND AGREE THAT EVEN IF BARK CENTRAL OR THE RELEASESS CHOOSE TO IMPLEMENT SAFETY PRECAUTIONS, SUCH ACTIONS SHALL NOT ALTER THE FACT THAT I HAVE RELEASES BARK CENTRAL AND THE RELEASESS FROM ANY DUTY TO PROTECT ME OR MY DOG(S).

- 15. **ATTORNEY FEES:** In the event of any dispute arising from this Agreement or from any Guest's attendance at Bark Central, I agree to immediately pay, on demand, all reasonable attorneys' fees and other costs incurred by Bark Central.
- 16. **ENTIRE AGREEMENT:** I understand that this Agreement contains the entire agreement between Bark Central and I. I agree that the terms and conditions of this entire agreement shall be binding upon me and my successors, heirs, legal representatives and assigns.
- 17. **WAIVER OF JURY TRIAL:** I HEREBY WAIVE ANY AND ALL RIGHTS TO TRIAL BY JURY AS TO ANY MATTER ARISING UNDER THIS AGREEMENT.

I HAVE READ AND FULLY UNDERSTAND THE TERMS OF THIS AGREEMENT AND UNDERSTAND THAT I HAVE GIVEN UP SUBSTANTIAL RIGHTS BY SIGNING IT AND SIGNED IT FREELY AND VOLUNTARILY WITHOUT ANY INDUCEMENT, ASSURANCE OR GUARANTEE AND INTENT IT TO BE A COMPLETE AND INCONDITIONAL RELEASE OF ALL LIABILITY TO THE GREATEST EXTENT PERMITTED BY LAW. I AGREE THAT IT IS INTENDED THAT ALL TERMS OF THIS AGREEMENT CONTROL DESPITE ANY PARTICULAR STATUTE OR LAW THAT WOULD OTHERWISE PROTECT ME OR MY DOG(S).
